## City of Frankfurt am Main improves compliance and efficiency

Frankfurt am Main is a significant financial centre and home to the European Central Bank. It is the most populous city in the state of Hesse, and the fifth-largest city in Germany. The city administration's IT landscape is complex, comprising many software manufacturers and licences. Professional support and an effective licence management tool are essential to maintaining an overview. However, implementing such a tool requires careful planning and consideration of the specific regulations of the public sector, which differ from those of commercial companies.

## The challenge

### Decentralised structures and manual processes

Frankfurt am Main faced the challenge of having no central tool or defined processes for city-wide operational licence management. Licence counts, e.g., for a Microsoft true-up, were carried out using a range of decentralised inventory solutions, including manual counts. This activity was time-consuming and resource-intensive. Frankfurt am Main needed a comprehensive solution enabling automated inventorying, accurate recording, and management of all software licences to simplify and expedite management.

The limited oversight and control over licence usage have led to potential compliance risks. It has been challenging to track software expenditures to avoid unnecessary costs. To address these issues, Frankfurt am Main, with the assistance of an experienced partner, planned to implement a licence management tool to optimise city-wide licence management.



Before introducing the licence management tool, we lacked efficient tools and clear processes. We aimed to establish operational licence management with a complete technical and commercial inventory and the associated processes.
