Overview of SoftwareOne group companies

The SWO group companes are subsidiaries of SoftwareOne AG (Switzerland), which again is held by SoftwareOne Holding AG, the ultimate parent company of the SoftwareOne group (SWO group) based in Switzerland.

The SWO group companies are local software sales and service companies responsible for acquiring new customers in their sales territory as well as maintaining existing customers and generating follow-up orders. The companies offer the SWO group's portfolio of software and cloud products as well as software and cloud services. This means in the Software & Cloud Marketplace business the company normally buys software or cloud solutions directly from third party publishers or in case of publisher restrictions via related parties (mainly SoftwareOne AG) resells the software with a margin to its customers. In the Software & Cloud Service business, the company sells the IT services portfolio to clients. Such services are either performed by own IT service personal resources of the other SWO group companies or resources, which SWO companies procure as a service from other SWO group companies.

All SWO companies offer their product portfolio under the SoftwareOne umbrella brand, which is a well-known brand in the global software and IT market.
