General overview of SoftwareOne group companies

SoftwareOne ("SWO") is a globally active software and cloud solutions provider that is supporting its customers in how to build, buy and manage everything in the cloud. With over 9,000 employees, the company offers a portfolio of 7,500 software brands with sales and delivery capabilities in 90 countries. The SWO group serves approximately 65,000 clients worldwide, including large enterprises, small and medium-sized enterprises (SMEs) and public sector organisations, across a range of end-markets.

The SWO group has about 60 subsidiaries operating as local software sales and service companies. They are responsible for acquiring new customers in their sales territory as well as maintaining existing customers and generating follow-up orders. The companies offer the SWO group's portfolio of software and cloud products as well as software and cloud services. This means in the Software & Cloud Marketplace business the sales companies buy software or cloud solutions directly from third party publishers or indirectly from related parties and resell to its customers. In the Software & Cloud Service business, the sales companies provide the IT services portfolio to clients. Such services are either performed by own local service personnel or through a SWO cross-delivery center operated by another SWO subsidiary.
